

2019 SOUTH RIVER GUN CLUB NRA APPROVED PRECISION PISTOL OUTDOOR TOURNAMENTS

DATES: MARCH 10, APRIL 20 (Saturday), MAY 11 (Saturday), JUNE 9, JULY 14, AUGUST 11, SEPTEMBER 15, OCTOBER 13, NOVEMBER 10.

Welcome to the South River Gun Club in Covington, GA and to the 2019 Approved Tournaments. Most months will be the second Sunday, except for April and May which are on Saturday to avoid other conflicts. Start time: Warm-up NMC starts at 0900 with the Approved 2700 Starting promptly at 10:00am. There will be a 20 minutes break between warm-up and Approved .22 start, a 15-minute break between .22 and center fire, and a 30-minute break between center fire and .45.

Eligibility: All shooters are welcome. Club membership is not required. NRA membership is strongly encouraged, but not required to compete. If 18th birthday occurs after the tournament date you **MUST** contact Art Rozier at the addresses below for a waiver form which must be signed by a parent and turned in at registration.

Entries: One relay, limited to 30 competitors

Entry Fee: \$5.00 for the warm-up NMC, this is included in the fee for any aggregate
\$20.00 for the 2700 aggregate (3 guns)
\$15.00 for an 1800 aggregate (2 guns)
\$10.00 for a 900 aggregate (one gun)

Registration: Registration for the approved match begins at 8:30 am and continues until the beginning of the three-minute preparation period for the .22 match.

Match #1: .22 Slow Fire; 20 rds @ 50 yds

Match #2: .22 National Match Course (30 rds)

Match #3: .22 Timed Fire; 20 rds @ 25 yds

Match #4: .22 Rapid Fire; 20 rds @ 25 yds

Match #5: .22 Aggregate of matches 1 thru 4.

Match #6 thru 10 Center Fire (same as 1 through 5 above)

Match #11 thru 15 .45 cal. (same as 1 through 5 above)

Match #16: Grand Aggregate, matches 5, 10 and 15
